**A RESOLUTION DESIGNATING POSTING LOCATIONS
FOR NOTICES OF PUBLIC MEETINGS**

WHEREAS, PALMER LAKE IS A STATUTORY TOWN ORGANIZED UNDER PART 3 OF ARTICLE 4 OF TITLE 31 OF THE COLORADO REVISED STATUTES; AND

WHEREAS, C.R.S. § 24-6-402(2)(C) REQUIRES ALL LOCAL PUBLIC BODIES, AT THEIR FIRST REGULAR MEETING OF EACH CALENDAR YEAR, TO DESIGNATE THE POSTING PLACES FOR POSTING NOTICES OF PUBLIC MEETINGS.




NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF PALMER LAKE, EL PASO COUNTY, COLORADO, AS FOLLOWS:

Section 1. Notices of regular and special meetings of the local public bodies of the Town of Palmer Lake, to include the Town Board of Trustees (Town Council), Planning Commission and Board of Adjustment, and any committees thereof, shall be posted in the following public places:

at Town Hall, 42 Valley Crescent St, Palmer Lake, CO 80133; and
at the Palmer Lake Post Office CO-105, Palmer Lake, CO 80133

Section 2. This Resolution shall be effective immediately.


