**A RESOLUTION TO AWARD AND AUTHORIZE AN AGREEMENT WITH  
CONTRACTOR FOR THE SOUTH VALLEY ROAD IMPROVEMENT PROJECT IN  
PALMER LAKE, COLORADO**

**WHEREAS**, the Town Board of Trustees has authority over contract agreements for the Town;

**WHEREAS**, a bid process and opening were conducted for the South Valley Road Improvement project for the Town of Palmer Lake; and


**WHEREAS**, four bids were received and staff will provide recommendation to award the bid based on the bid tab review.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE  
TOWN OF PALMER LAKE, COLORADO AS FOLLOWS:**


1. The Town Board of Trustees hereby awards the bid to the recommended contractor, as identified in Exhibit A.
2. The Town Board further authorizes entering into an agreement approved by the Town Attorney with the awarded bidder to complete the South Valley Road Improvement project.
3. Severability. If any article, section, paragraph, sentence, clause, or phrase of this Resolution is held to be unconstitutional or invalid for any reason such decision shall not affect the validity or constitutionality of the remaining portions of this Resolution. The Board of Trustees hereby declares that it would have passed this resolution and each part or parts thereof irrespective of the fact that any one part or parts be declared unconstitutional or invalid.
4. Repeal. Existing resolutions or parts of resolutions covering the same matters embraced in this Resolution are hereby repealed and all resolutions or parts of resolutions inconsistent with the provisions of this Resolution are hereby repealed.
